
On December 23, 2016, the Petitioner filed a *Petition for Judicial Review* in the above-captioned matter. *Notices of Appearance* were subsequently filed by the South Valley Ground Water District, A&B Irrigation District, Burley Irrigation District, Milner Irrigation District, North Side Canal Company, Twin Falls Canal Company, American Falls Reservoir District #2, Minidoka Irrigation District, City of Pocatello, City of Bellevue, City of Hailey, Water District

37B Groundwater Association, and the Idaho Ground Water Appropriators, Inc. Pursuant to the *Procedural Order* issued by the Court, the *Notices of Appearance* will be treated as *Motions to Intervene*. The Court finds that the *Motions to Intervene* are unopposed, as no party has objected to the movants participating in this proceeding. This Court thus finds that the movants are real parties in interest to this proceeding and have interests that could be affected by the outcome of this proceeding. Therefore, in exercising its discretion, this Court finds that the movants are entitled to leave to intervene as parties to this proceeding.
