## I. FINDINGS OF FACT

Claims were filed for these water rights by the United States Department of Agriculture Forest Service ("Forest Service") for federal reserved water rights in the Idaho Panhandle National Forests and the Nez Perce Clearwater National Forest. The elements of these rights were reported by the Idaho Department of Water Resources in abstracts of the notices of claim.

# II. PROCEDURAL BACKGROUND

Originally, the Forest Service filed a total of six claims (91-7729, 92-10890, 92-10891, 93-7433, 94-9133, and 95-16527) for these forests. The State of Idaho filed a *Motion for Summary Judgment* asserting the claims did not adequately identify the elements of each water right. Additional parties joined the motion. The Special Master ruled that these federal reserved water rights were required, under I.C.§42-1409, to further describe each element. *Order on Summary Judgment* at 22. (Aug. 1, 2016) (Subcase 91-7729 et. al.) The exception is for federal reserved rights with a firefighting purpose. Those rights are not constrained by I.C. §42-1409. *Id.* at 21.

The Presiding Judge upheld the summary judgment decision on permissive review, holding that the United States is not excused from the requirements of I.C. §42-1409. *Memorandum Decision and Order* (June 1, 2017) (Subcases 91-7729, et.al.) at 7, 12.

In 2018, the United States filed Amended Claims for its federal reserved water rights to comply with the *Order on Summary Judgment* and *Memorandum Decision and Order*. The 2018 Amended Claims expanded the Forest Service claims from six subcases to 259 subcases,

including 91 Surface Water Fire Suppression claims, 91 Surface Water National Forest Administration claims, 36 Ground Water Fire Suppression claims, 36 Ground Water National Forest Administration claims, and 5 Ground Water National Forest Future Administrative claims.

The Court designated five lead subcases, which included one subcase from each of the five groups. *Order Designating Lead Subcases, Setting Deadlines, and Trial Date* (Mar 5, 2019) (Subcases 91-07931, 91-07963, 91-07995, 91-08007, and 91-08019). Subsequently, the parties filed *Objections* and *Responses* in 2019. The parties filed requests for discovery and various motions. The Court held multiple status conferences and ordered settlement conferences throughout 2019, 2020, and 2021. The parties reached an agreement at the end of 2021.

The agreement of the parties involved reconfiguration of the 259 water rights. The agreement sanctioned splitting the Forest Service rights into 510 subcases for Surface Water Fire Suppression, 510 subcases for Surface Water National Forest Administration, 36 subcases for Ground Water Fire Suppression, 36 subcases for Ground Water National Forest Administration, and 5 subcases for Future Administrative sites. Thus, the parties agreed on a final list of 1097 subcases. A *Stipulation and Joint Motion for Order Approving Stipulation* was filed by the parties on February 1, 2022. The 36 subcases in this Group 3 (Ground Water - Fire Suppression) were not reconfigured or split after the amended claims in 2018. All parties to the subcases and IDWR are signatories to the *Stipulation*.

It should be noted that some of these subcases and attached maps include some elements which are outside the state of Idaho. Those elements outside of Idaho are included for identification and clarification. Nothing in this *Special Master's Report and Recommendation* alters the jurisdiction of the courts of other states.

# III. CONCLUSIONS OF LAW

Based on the file and record herein, IT IS RECOMMENDED that these water rights be **decreed** with the elements set forth in the *Special Master's Recommendation* posted on the Court's web site at <a href="https://www.srba.idaho.gov/CSRBA25.HTM">www.srba.idaho.gov/CSRBA25.HTM</a>, as stipulated to by all parties.


