I. FINDINGS OF FACT

A notice of claim was filed for this water right pursuant to I.C. § 42-1409. The Director of the State of Idaho Department of Water Resources examined the water system for this reporting area. The *Director's Report* contained a recommendation for the elements of this water right.

An Objection was filed by the United States Bureau of Land Management on July 26, 2022. A Standard Form 5 was filed on April 3, 2024. All parties to the subcase and IDWR are signatories to the Standard Form 5. The parties stipulated that this water right should be disallowed and not be included in any partial decree.

II. CONCLUSIONS OF LAW

Based on the file and record herein, IT IS RECOMMENDED that this water right **not be confirmed** in any partial or final decree.


