I. FINDINGS OF FACT


A notice of claim was filed for this water right pursuant to I.C. § 42-1409. The Director of the State of Idaho Department of Water Resources examined the water system for this reporting area. The *Director’s Report* contained a recommendation for the elements of this water right.

No objections were filed for this water right and the time for filing objections has expired. This water right and related water rights were listed on the same *Director’s Report* filed May 25, 2022. This water right was retained while the related contested rights reached settlement. Since the related rights have now been resolved, this water right is recommended consistent with the *Director’s Report* filed on May 25, 2022.

II. CONCLUSIONS OF LAW

Therefore, based on the file and record herein, IT IS RECOMMENDED that this water right be **decreed** with the elements set forth in the attached *Special Master’s Recommendation for Partial Decree*.


