On June 18, 2026, the Court entered a Procedural Order. It directs that the agency record and transcript be lodged with the agency on or before July 2, 2026, and that the settled agency record and transcript be lodged with the Court on or before July 30, 2026. On June 30, 2026, the Respondents filed a motion requesting the deadline to lodge the agency record and transcript with the agency be extended to July 16, 2026, due to staff workload. Further, that the deadline to lodge the settled record and transcript with the Court be extended to August 13, 2026. The Court in an exercise of its discretion will grant the motion. The motion also asks that oral argument, presently set for November 5, 2026, be vacated and reset for a date after November 19, 2026.

THEREFORE, BASED ON THE FOREGOING, THE FOLLOWING ARE HEREBY ORDERED:

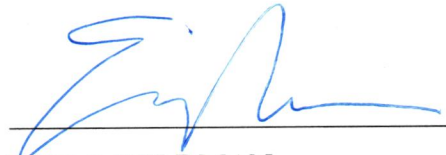
1. The motion for extension of time is granted.
2. The deadline to lodge the agency record and transcript and with the agency is extended to July 30, 2026.

3. The deadline to lodge the settled agency record and transcript with the Court is extended to August 13, 2026.

4. The oral argument hearing presently set for November 5, 2026, is hereby vacated.

5. Oral argument is reset for **December 3, 2026, at 1:30 p.m. (Mountain Time)** at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Oral argument will be conducted via Zoom with instructions to be provided to the parties at a later date. The form and order of argument shall be governed by I.A.R. 37.

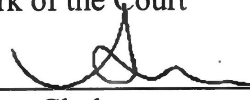
